AMENDMENT TO THE DECLARATION OF CONDOMINIUM OF BUENA VISTA CONDOMINIUM

WHEREAS, the Declaration of Condominium of Buena Vista Condominium, dated December 9, 1983, and recorded in Miscellaneous Book 47, Pages 717-742 inclusive, of the records in the office of the Judge of Probate of Baldwin County, Alabama, as amended; and,

WHEREAS, the owners of the units of Buena Vista Condominium do wish to amend and revise the Declaration of Condominium of Buena Vista Condominium according to Article Sixteen of said Declaration of Condominium; and,

WHEREAS, notice of the subject matter of this proposed revision was included in a notice of a general meeting given to all unit owners held on the 17th day of May, 2003; and,

WHEREAS, a Resolution having been adopted and approved prior to that time, by a majority of the Board of Directors proposing the revision given below; and,

WHEREAS, said proposed revision was approved by a three-fourths (3/4) majority of the votes of the unit owners according to their proportional ownership.

THEREFORE, THE DECLARATION OF CONDOMINIUM OF BUENA VISTA CONDOMINIUM SHALL BE AMENDED AS FOLLOWS:

Article Twelve, Subparagraph 2, is amended to read as follows:

2. The association may assess and collect funds and may pay for common expense (and limited common expenses, if any) out of such funds as are appropriate. The power of the Association through its Board to assess and collect funds, shall include the authority to make regular and special assessments for the management of the Association, the right to assess a reasonable rate of interest on past due amounts when regularly or specially assessed by the Association, and reasonable penalties for any administrative or management expense in securing compliance of the owner in the discharge of their periodic responsibility including the assessment of costs and attorney's fees when process of law is necessary.
