AMENDMENT TO THE BY-LAWS OF

BUENA VISTA CONDOMMNIMUM OWNERS' ASSOCIATION, INC.

The Board of Directors of Buena Vista Condominium Owners' Association, Inc. hereby wishes to amend and revise the By-Laws of the Buena Vista Condominium Owners' Association, Inc. in accordance with Paragraph 30 of such By-Laws;

Further, the By-Laws of Buena Vista Condominium Owners' Association, Inc. are hereby amended as follows:

PARAGRAPH 1.

The first sentence of this paragraph shall be replaced to read: The principal office and mailing address of Buena Vista Condominium Owners' Association, Inc. shall be Buena Vista, P.O. Box 704, Guif Shores, Alabama 36547-0704.

PARAGRAPH 4.

The first two sentences of this paragraph shall be replaced to read: There shall be an annual meeting of the members of the corporation held each year, the date of which shall be set by the Board of Directors. Notice of the date, place and time of each annual meeting shall be forwarded to each member (whether or not designated as a voting member) by a representative of the Board, by mail or other electronic transmission, not less than ten (10) nor more than sixty (60) days prior to the meeting.

PARAGRAPH 12.

Paragraph 12 shall be replaced in its entirety with the following: There shall be regular meetings of the Board of Directors immediately prior to and following all meetings of the members and at least one other time each year, the date, time, and place to be designated at the meeting next following the meeting of all members, however special meetings may be called when needed in accordance with directions set out under Paragraph 13.

PARAGRAPH 26.

PARAGRAPH 26, as amended shall be replaced and read as follows: The registered agent shall maintain the corporation's mailing address, shall report the same to the Alabama Secretary of State, as required by law, and shall report all corporate communications received to the corporation's Board of Directors. The resident agent, who must be a resident agent of Buena Vista Condominium Owners' Association, Inc., as of the date of amendment of this section of these By-Laws is:
